As we move into the new academic year it is important for Pembroke to share with you information regarding the importance of school attendance; new guidance from the Department for Education (DfE); and updated policies on attendance.

The DfE guidance identifies that pupils need to attend school regularly to benefit from their education. Missing out on lessons leaves children vulnerable to falling behind. Children with poor attendance tend to achieve less in both primary and secondary school. The government expects schools to promote good attendance and reduce absence, including persistent absence (a child is considered to be persistently absent if their attendance drops below 90%). In the event that you have any concerns about your child attending the academy, please do not hesitate to contact us to discuss available support.

The table below shows the number of days' absence over a year that equate to each percentage absence.

<b>Percentage Attendance</b>	<b>Approximate number of days absent</b>
95%	10 (2 x weeks)
90%	19 (nearly 4 x weeks)
85%	29 (nearly 6 x weeks)

As an academy, our aspiration for all pupils is that their attendance is 100%, in order for them to get the best from their learning. We understand that there may be times when absence is unavoidable. However, where it is avoidable, I ask that you work with the academy and ensure your child(ren) is/are in school. In accordance with the DfE, any pupil with an attendance level of 90% or less, or who has more than 4.5 days of unauthorised absence in a 6-week period, may receive a fixed penalty fine, or other legal intervention.

We would like to draw your attention to the following government legislation:

- Section 7 of the Education Act 1996 places upon parents a duty to ensure that their child receives efficient full-time education either by regular attendance at school or otherwise.
- Where a child is a registered pupil at a school and the parent fails to ensure that child's regular attendance at school, the parent is liable to be prosecuted for a criminal offence under Section 444 of the Education Act.

- In cases where this duty is not being fulfilled, Section 444B of the same Act empowers the Local Authority to issue a Fixed Penalty of either £60.00 or £120.00.


Punctuality to school is also vitally important. Pupils who arrive late to the academy have an unsettled start to the day and this can disrupt their own learning, as well as that of their peers. In addition, punctuality is a key life skill that we are keen to promote and reinforce. As a result, persistent lateness will be challenged, and sanctioned, where appropriate. I would urge you to contact the academy if you feel you would benefit from any support around this.

In respect of holidays during term time, in line with our [Attendance Policy](#) and the DfE guidance, the Headteacher will only grant a leave request in exceptional circumstances (to be determined by the academy). Parents/Carers who believe they have exceptional circumstances must make a request for a leave of absence to the Headteacher no less than one month prior to the holiday (a form can be obtained from the academy reception). If the circumstances are not considered to be exceptional, and permission to take a term-time holiday is not granted by the Headteacher, but the holiday is still taken, the absence will be recorded as unauthorised and a Fixed Penalty Notice may be issued by the Local Authority. Whilst we appreciate that families may have to re-arrange postponed holidays as a result of the coronavirus pandemic, we ask families to avoid taking their child(ren) out of the academy during term time when they have already missed so much learning time.

As a reminder, if your child is unable to attend the academy, please ensure that you notify us as soon as possible. You should ring 01522 751 040 and choose option 3. If your child's absence goes beyond one day we need to be contacted on each subsequent day of absence.

Once again I would like to thank you for your continued support with your child(ren)'s education.
