## Dear Parents/Carers

Welcome back to a new module and we hope you all had a relaxing Easter break.

I am writing to update you on the COVID19 procedures and the most recent updates.

It has been confirmed that face coverings will continue in schools. It will next be reviewed in line with the government roadmap on the 17<sup>th</sup> May 2021. It is therefore important that all students have a face mask along with a spare.

The government has urged us all not to become complacent in our approach to COVID19. In school we will continue with the one way systems, staggered breaks, set seating plans, enhanced cleaning and the regular use of hand sanitizer.

It is also important that we all carry out the twice-weekly LFD tests. It is imperative that we report the results to the NHS and school. Everyone should now be in a good routine of doing this.

The Government have updated the guidance to say that any LFD test completed at home or school now needs to be followed up by a PCR test if the LFD is positive. I hope that this will simplify the process and understanding. PCR tests can be booked through the NHS website. Self-isolation is necessary until all results are known. ## Information from the government - Financial support if you have to take time off work to care for your child while they are self-isolating

If you are on a low income and you need to take time off work to care for your child while they are selfisolating, you may be eligible for financial support from your local authority through the Test and Trace Support Payment scheme.



The Test and Trace Support Payment scheme is open to people who live in England and who meet the following criteria:

- They are the parent or guardian of a child or young person in the same household and need to take time off work to care for them while they self-isolate; this is limited to one parent or guardian per household for the child or young person's self-isolation period
- Are employed or self-employed
- Are unable to work from home while undertaking caring responsibilities and will lose income as a result
- They are currently receiving or are the partner of someone in the same household who is receiving at least one of the following benefits:
  - Universal Credit
  - Working Tax Credit
  - o income-based Employment and Support Allowance
  - o income-based Jobseeker's Allowance
  - Income Support
  - Housing Benefit
  - Pension Credit
- Their child or young person:
  - is aged 15 or under (or 25 or under with an Education, Health and Care Plan (EHC) and normally attends an education or childcare setting
  - has been told to self-isolate by NHS Test and Trace or by their education or childcare setting because they have been identified as a close contact of someone who has tested positive for COVID-19

Discretionary payments are also available for people on low incomes who are not on means-tested benefits but who may still face hardship as a result of the requirement to self-isolate. Your local authority may have additional eligibility criteria in place for discretionary payments.

If you are eligible, you will receive a £500 payment from your local authority in addition to any benefits and Statutory Sick Pay you receive currently. If you are unsure which local authority you should claim from, you can check on Find your Local Council on GOV.UK: <u>https://www.gov.uk/find-local-council</u> **Your local authority will contact your child's school to verify the information you provide about your child as part of the process of confirming whether you are eligible for a payment.**

If you think you meet the eligibility criteria listed above and would like to apply to your local authority for a payment from the Test and Trace Support Payment scheme, you should contact Mr Bibby who will provide you with a letter to share with your local authority to support your application. **You will not be**  able to make an application for a payment from the Test and Trace Support Payment scheme without this letter.
